- (10) Motion made by Commissioner Hanna, seconded by Commissioner Nichols and unanimously adopted by the Court acknowledging the District Court's order concerning compensation for the County Auditor and Assistant Auditors for 2024.
- (11) Motion made by Commissioner Nelms, seconded by Commissioner Nichols and unanimously adopted by the Court to accept donation from Eagleclaw Midstream to sheriff's office.
- (12) Motion made by Commissioner Nichols, seconded by Commissioner Sanchez and unanimously adopted by the Court approving increase in pay for employee at the golf course.
- (13) Motion made by Commissioner Sanchez, seconded by Commissioner Hanna and unanimously adopted by the Court to acknowledge audit for County Treasurer's general fund and TexPool fund.
